### Exam A

### NEW YORK STATE MODIFICATIONS AND POINTS OF EMPHASIS

4. The R-2 notifies the R-1 and the appropriate coach(es) when the 15th through 18th substitutions are taken.
12. In the first set, Team A's # 3 displays minor unsportsmanlike conduct by addressing the linesperson's call. The R-1 sanctions #3 with an individual red card.

### MOST MISSED QUESTIONS

14. During play the R-2 whistles and signals a fault by a player contacting the net outside the antenna.
19. A spiked ball that goes into the net and lands out of bounds on the attacker's side is signaled by raising the forearms vertically, elbows at 90 degrees with palms facing the shoulders.

### OFFICIAL'S MECHANICS, RESPONSIBILITIES AND SIGNALS

29. The R-2 notices that team B's left back is partially off the court. The ball is legally served and upon service contact the R-2 whistles and points with index finger, arm extended, to the side line where the violation occurred.

### PROTOCOL

42. If a playing captain lodges a protest, an opposing coach is allowed to participate in the discussion.

### STATES OF PLAY

56. There is 7 feet of free space between the referee's platform and the spectator area and more than 12 feet of free space from the net standard to the score table on the bench side of the court. The referees decide the pursuit rule will not be used for the contest.
62. After setting the ball, Team A's setter's elbow brushes against the net. It does not change the integrity of the net nor distract any of the players involved in the play. The R-2 whistles a net violation on the setter.
72. As Team A's # 11 prepares to serve, Team A's center front takes a position close to the net directly in front of Team B's center front. The R-1 verbally warns Team A's center front to move sideways or bend down because of the potential screen.

### SANCTIONS

86. Between sets three and four Team A's #23 comments to Team B and displays minor unsporting offenses as the teams change sides. The R-2 requests the R-1 to assess a yellow card warning to Team A's # 23. The R-2 immediately communicates the sanction to both the captain and the coach.
88. Any sanctions assessed between sets are administered before the start of the next set. The R-1 must show either the yellow or red card prior to the start of the set.

### **SCORING (refer to attached scoresheet)**

- 93.** Team A's #12 is injured and unable to continue. All substitutes on the bench have played in the set in other positions. An exceptional substitution is granted. The scorekeeper circles Team A's #12 and records the uniform number of the player entering the set for #12 in the "Players' Numbers" column on the score sheet. The event is also recorded in the comments section of the score sheet.
- 94.** The assistant scorekeeper (libero tracker) will record all substitutions, libero replacements and the first serve for each player's term of service on the libero tracking sheet.
- 98.** According to the scorekeeper, the score for Team A is 14 and the score for Team B is 15; however, the visible score shows 15-15. After discussing the discrepancy with the R-1, the R-2 modifies the score sheet to reflect the correct score of 15-15. This is proper procedure when addressing a possible scorekeeper recording error.
- 100.** Team A's coach is granted a time out. The scorekeeper records 12-15 in the first time out box for Team A. During the time out, the R-2 verifies the score is correct as recorded and each team has used six substitutions.
